

## Terms and Conditions of Enrollment Summer 2021

- 1. I understand that following acceptance of enrollment, camp must receive all forms prior to June 1st. I also agree to advise the camp director prior to my child's camp session of any last-minute medical conditions.
- 2. I understand that Sportsclub Kids reserves the right to refuse a camper or to cancel any camper enrollment if the camper's forms are deemed unacceptable. Sportsclub Kids also reserves the right to discharge a camper whose conduct is unacceptable. In such a case, unused camp fees will not be refunded.
- 3. I understand there is no allowance or refund for absences, missed days, late arrival, dismissal, or early withdrawal of campers.
- 4. <u>I understand all camp payments are refundable less a \$25 per week deposit through May 1, 2021. Payments are due on May 1, 2021. All changes in weeks of attendance must be made at least 14 days prior to the start of the week in question. There are no refunds after May 1, 2021. This policy applies to payments made as well as payment plan commitments.</u>

## 5. COVID-19 Refund Policy:

Sportsclub Kids will refund all deposits and fees related to 2021 summer camps should the facility be forced to close as a result of the Covid-19 pandemic and related directives from federal, state, or local authorities. Refunds will be issued 45 days from the closure date. A member may elect to forgo the refund option and have the amount due + 10% applied to a future Sportsclub camp in 2022 or beyond.

A \$25 per week per child deposit is required for Sportsclub Kids Camps. If a member chooses to cancel their reservation and Sportsclub Kids is in operation, the deposit will be refunded within 45 days of the request minus a \$75 administrative fee or the member may apply the deposit towards 2022 summer camps. Cancellations within 7 days of a camp week will be forfeited in full.

- 6. I understand a \$35 charge will be made on any returned checks.
- 7. I agree to pay for extended day if my child is dropped off prior to 8:50 AM or picked up after 4:15 PM. I understand I will be charged a late fee of \$1/minute if my child is not picked up by 6:00 PM.
- 8. I allow any third-party hospital, doctor, etc. to release to Sportsclub Kids any information regarding my child's medical condition. I understand that Sportsclub Kids reserves the right to send my camper home, to hospitalize my child should the need arise, or to seek outside medical attention. All related expenses will be paid by me or my insurance.

- 9. I understand that camp is not responsible for campers' equipment or personal belongings, although effort will be made to safeguard possessions. Expensive clothing, jewelry, electronic devices including music players, cameras, and hand-held video games, and other expensive items should not be brought to camp. Cell phones are not permitted in camp.
- 10. I give permission that any photographs, videos, or interviews taken of my child may be published and used to illustrate, promote, and advertise Sportsclub Kids. If I do not wish to have pictures of my child published or used, I will inform Sportsclub Kids in writing.
- 11. I give permission for my child to be taken out of camp for special activities and trips. I am aware that there are inherent risks associated with transporting my child to and from field trips at Sportsclub Kids as well as with participating in Sportsclub Kids programming. I, on behalf of the child(ren) named above, knowingly and freely assume all such risks, both known and unknown, including those that may arise out of the negligence of others. Furthermore, for myself and my child(ren) and our respective heirs, assigns, administrators, and personal representatives, hereby release and hold harmless World Indoor Sports, Inc., d/b/a Sportsclub Kids, their affiliates, officers, members, agents, employees, and other participants from and against any and all claims, injuries, liabilities, or damages arising out of or related to participation in camp.
